**I. CALL TO ORDER**

**II. PURPOSE:**

**A. Ordinance 2019-19. An ordinance to reduce the speed and/or volume of traffic through the modification of driver behavior in our neighborhoods.**

**B. Ordinance 2019-20. An ordinance to amend Chapter 4, "Buildings and building regulations", Section 4-1, "Adoption of codes by reference" of the code of ordinances of the Town of Port Royal South Carolina to adopt the international building codes with South Carolina building code modifications.**

Ms. Judy Ailing asked if this would require a lot of changes to the Town's code. Ms. Linda Bridges stated there are typically few changes. She did hear one of the changes would be recognizing hempcrete as a building material.
