He said this ordinance would remove the loophole and require anyone who rents or leases non-residential properties in the town to purchase a business license.

Town Manager Willis briefed Council on the following issues:

- Stormwater drainage underway on 8th Street, 10th Street and Madrid Avenue, Duckblinds Pond and Cypress Wetlands
- TIF spending moving forward with mast arm signals for Lady's Island Drive and Ribaut Road under construction
- Port property vote by Budget and Control Board delayed until September meeting

- Landscaping, fence, sidewalk and plantings will be installed at the end of Columbia Avenue
- Waiting to plant beds in front of school until street lights are installed
- Light audit being conducted by SCE&G and Planning Administrator Bridges
- Northern Regional Plan, still working on Form Based Code; funded Phase 1 only, will determine later whether Phases 2 and 3 will be beneficial to the Town
- Metro Planning Commission approved by City of Beaufort and the Town; now in subcommittee at county level
- Still finalizing year end financials, will schedule audit to be completed by end of calendar year
- Legal issues, Delta Beaufort Partnership lawsuit dismissed
- Town awarded grant for Ft. Frederick Sewer Project
- Visitor Center and walking tour map, possibility of locating visitor center at the Estuarium location
- Working with state official to update 11th Street Church submittal for designation on Federal Register
- Recycling of yard debris, considering processing yard debris through LCR; working to compare cost
- Public Works, working with ATM engineer to develop a work-order to provide better performance of that department
- Code Enforcement, looking for more systematic approach with comprehensive coverage of the town

Town Manager Willis told Council Ordinances 2010-7 and 8 had been removed from the agenda. He reviewed Ordinance 2010-9 which would close a loophole in the Business License ordinance that excludes landlords of non-residential buildings making less than twelve thousand dollars per year from purchasing a business license.

Town Manager Willis told Council reappointments were needed to the Redevelopment Commission and the Zoning Board of Adjustments and Appeals. He reviewed the list of important information and dates. Mr. Willis told Council he had received a letter from the Department of Transportation which stated the re-designation of Highway 21 through Port Royal would not take place until certain requests have been fulfilled and local agreement to the change has been reached.

Councilmember DeLoach expressed concerns about golf carts riding on the Cypress Wetlands boardwalks. He suggested that signs be posted to keep motorized vehicles off the boardwalks.

John Ellerbe told Council the Walking Tour maps were almost completed and that the ad sales were very good. He credited Daria Paterson with the good sales.
